

## SPORTS SCHOLARSHIP POLICY

EISB through its, **'Sports Scholarship Policy'**, offers the opportunity to meritorious students to be a part of a learning environment that appreciates merit in **Sports**. Existing students of EISB and new students seeking admission can apply for this scholarship.

For existing students of EISB, accomplishments of only the current academic session will be considered for the scholarship in the current academic session. For new students, the accomplishments of the previous/first academic session will be considered for the scholarship in the first academic session. An achievement/accolade cannot be reused for scholarship in the subsequent year. Students can improve their performance and can apply for a higher percentage of scholarship in the current/subsequent year, and in the case of a drop in the performance in the subsequent year, the category of the scholarship will also drop down.

To apply for this scholarship, the student should have participated in an Internationally recognised sporting event at the International, National, State, Zonal or District level and won a Gold/Silver/Bronze medal (Individual Sport, recognised by IOC/IOA), secured <sup>1st</sup> Position/<sup>1st</sup> Runner-up, in Lawn Tennis, hosted by AITA or representing BCCI/KSCA in cricket. The event should be hosted by Nationally/ Internationally recognised Athletics/Sports Federations or sports associations having the relevant affiliation.

## \*Terms & Conditions Governing the Sports Scholarship Policy:

- 1. If a student is extended/offered more than one concession/scholarship, the highest applicable amount will be considered. Only one concession/scholarship from the various categories can be availed in any one academic year. No two concessions/scholarships can be availed/combined together.
- 2. The scholarship amount is strictly restricted/calculated on a pro-rata basis only on the Annual Tuition Fee as per the Fee Structure of the respective grade. All other applicable fees are payable.
- 3. After availing of the concession, if all the applicable fees are paid as a one-time down payment, an additional rebate will be awarded on the discounted annual tuition fee payable as per the following table:

- 4. An application will have to be submitted in the prescribed format available with the school, along with all the relevant supporting documents.
- 5. The scholarship is valid only for one academic year. A fresh application with relevant supporting documents will have to be submitted in the subsequent year (if applicable).
- 6. All decisions for the selection of students for the scholarship are at the discretion of the management, and no representation will be accepted.
- 7. Intimation of scholarship approval will be made in writing, duly signed by the management representative. No oral confirmation will be considered.
- 8. The scholarship amount will be adjusted only against the last fee instalment(s) as per the fee structure.
- 9. The management at any time may withdraw the scholarships offered without any prior notice.
